**Contract Title: REHABILITATION OF SADAR AL-NAHR BRIDGE IN KIRKUK GOVERNORATE

The Government of Iraq has received an additional financing from the World Bank toward the cost of the EMERGENCY OPERATION DEVELOPMENT PROJECT (EODP), and intends to apply part of the proceeds toward payments under the contract for **(Rehabilitation Of Sadar Al-Nahr Bridge In Kirkuk Governorate)** with a cost estimate of USD 1,750,000 (one million and seven hundred fifty thousand US dollars)

The Cost estimate is indicative, and bidders need to bid based on their own estimate. The Cost estimate is indicative. The Bid will not be rejected based on comparison with the Cost Estimate and bidders need to submit their bids based on their own estimate. The Ministry of Construction and Housing and Municipalities and Public Works/Roads and Bridges Directorate now invites sealed bids from eligible bidders for Rehabilitation of all items of project including but not limited to:

- a- Providing equipment necessary to lifting the soil, earth soil fill, demolition and removing of all parts of superstructure for spans (S2, S3,S4,S5,S8,S9) including (Deck slab, asphalt wearing, sidewalk, girder,...etc.) and all incidentals by method that keeps the structure safe, then lifting and transporting concrete rubbles from the project site to a construction waste disposal area according to a method proposed by the contractor, reviewed by the R.E. and approved by the employer;
- b- Demolition and removing of piers (2,3,4, others if needed), after conducting structural evaluation and safety test for piles;
- c- Casting reinforced concrete type (D20) for piles (1.20m) if needed;
- d- Casting concrete type D20 for piers and pier cops for and damaged abutment in accordance with the drawings and technical report;
- e- Placement of reinforced elastomeric bearings, Providing and transportation and placement of reinforced concrete girders (pre cast pre stress) in accordance with the drawings;
- f- Casting of reinforced concrete for the deck slab, diaphragm and sidewalks;
- g- spreading hot polymer modified asphalt wearing course, providing and replacement of expansion joints, installation of hand rails and turning on lighting for the bridge.

The contractor may propose any other alternative methodology, provided that it does not exceed the cost estimate and in accordance with the general specifications of roads and bridges.

Foreseen construction period is: **300 calendar days.**

Bidding will be conducted through the National Competitive Bidding procedures as specified in the Bidding documents. A complete set of bidding documents in Arabic may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of IQD 250,000. The method of payment will be in cash. Bids must be Sealed and delivered at the address below, enclosing the following documents:

- 1 Copies of documents specifying the legal status, place of registration, the location of the main bidder and an official agency for the site on the bid to legally bind him to the bid submitted by him, and in the event that the bidder is a consortium of joint venture or corporate partners. Legally in accordance with the provisions of paragraph (2.2 h) of the instructions to bidders;
2. The total value of project work completed in the years (2016-2021) by selecting the four years with the highest financial value within the mentioned period, according to what was stated in the bidding documents;
3. Submit a detailed statement with the price break down of the priced items in the bill of quantities for the above project (details of the cost of each item in the bill of quantities separately and their price break down in detail) according to what was mentioned in the bid documents.

4. Experience in executing works similar in nature and size to the above project in the years (2014-2021). The details of each work that is still in progress or under contract, and the employers who can be contacted to obtain additional information on these contracts. According to what is stated in the bid documents;
5. A list of the main equipment proposed for executing the contract along with its ownership statement documents, as stated in the bid documents;
6. Qualifications and experiences of personnel in the site management and the proposed technicians for the implementation of the contract, as stated in the bidding documents;
7. Reports on the financial position of the bidder, such as profit and loss statements and auditor's reports for the years (2014-2021);
8. Bank certificates or statements confirming the availability of the working capital for this contract (the available credit facilities and other available financial resources). As stated in the bidding documents;
9. A letter of authorization authorizing the employer to review the bidder's banks to ascertain his financial status;
10. Information about any court cases during the past five years, in which the bidder was or was one of its concerned parties, along with the different amounts and dues thereon;
11. The bidder shall present program for executing the work and how to reach the site (the timetable for progress of work, the mechanism for executing the work, machinery, equipment and staff, the contractor's department site) in accordance with the approved engineering programs as stated in the bidding documents;
12. Suggestions about the work items to be given to subcontractors, which do not exceed 20% of the total contract according to the bidding documents.

Bids must be delivered to the address below before **11:00 AM, Wednesday, December 15, 2021. Electronic bidding will not be permitted.** Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below on **11:00 AM, Wednesday, December 15, 2021.**

All bids must be accompanied by a "Bid Security" (The bid security of a JV shall be in the name of the JV that submits the bid. If the JV has not been legally constituted into a legally enforceable JV at the time of bidding, the bid security shall be in the names of all future members as named in the letter of intent).
